 (Parties larger than 50 people will need to pay for extra lifeguards, \$25 per hour, per guard)

Rental fee is \$100 (non-refundable) for the pool and \$150 (non-refundable) to rent the pool and clubhouse, plus the lifeguard fee paid to Trinity Creek HOA. Please make pool/clubhouse/lifeguard checks to Trinity Creek, PO Box 1044, Jenks, OK 74037 or they can be placed into the drop box at the Clubhouse. ACH is also available. Reservation requirements:

1. \$100 must be paid for pool rental/\$150 for pool and clubhouse, plus lifeguard fee.
2. Any damages to the pool or property will be billed back to the homeowner at HOA Board discretion.
3. All pool rules listed must be followed and pool/pool deck must be clean of spills, debris, and trash.
4. HOA dues must be current.
5. Reservations can be made by residents only.
6. All parties must be chaperoned by a responsible adult.

*\* All checks are refundable for weather cancellations. No refund of pool rental fee for non-weather cancellation that occurs less than seven (7) days from reserved date. Rental is not confirmed until payment is received for Pool and Lifeguards.*
